RESOLUTION NUMBER 0673 OF JULY 24, 2018

Through which the License for the cultivation of non-psychoactive cannabis plants, granted through Resolution 0230 of March 7, 2018, is modified.

**THE SUB-DIRECTOR FOR CHEMICAL SUBSTANCES' AND NARCOTICS'
CONTROL AND SURVEILLANCE OF
THE MINISTRY OF JUSTICE AND LAW**

Exercising her powers, particularly those granted in Act 1787 of 2016, Decree 1427 of 2017, Decree 613 of 2017, consistently with that provided for in Resolutions 577 and 578 of 2017 of the Ministry of Justice and Law and, applying the provisions under the Administrative Procedure and Contentious Administrative Code, and

CONSIDERING

That through filing EXT18-0000404 of January 4, 2018, company SATIVA NATIVA S.A.S., identified with TIN. 901.038.229-2, applied for a License for the cultivation of non-psychoactive cannabis plants in the modalities of: (I) Production of grain and seeds for planting; (II) Manufacture of derivatives; and (III) Industrial purposes, which was granted through Resolution No. 0230 of March 7, 2018.

That through filing EXT18-0018810 of May 9, 2018, Mr. Lucas Pablo Nosiglia, identified with foreign identification card No. 780.871, in his capacity as legal representative for SATIVA NATIVA S.A.S., identified with TIN. 901.038.229-2, hereinafter the applicant, submitted an application for modification of the License for the cultivation of non-psychoactive cannabis plants, due to a change in connection with the legal representation.

That complying with paragraph 3 of Article 2.8.1.1.2.1.4 of Decree 780 of 2016 (article 1 of Decree 613 of 2017) and paragraph 1 of Article 5 of Resolution 577 of 2017 of the Ministry of Justice and Law, consistently with that provided for in Resolution 578 of 2017 of the Ministry of Justice and Law, the applicant submitted the documentation required to evaluate the requirements' compliance and modify the License for the cultivation of non-psychoactive cannabis plants, due to a change in connection with the legal representation.

That from the study of the documentation in the administrative record and the abovementioned legal provisions, it is established that the applicant complies with all the requirements, which allows to conclude that the modification of the License for the cultivation of non-psychoactive cannabis plants, granted through Resolution No. 0230 of March 7, 2018, due to a change in connection with the licenseholder's legal representation, is viable.

In light of the foregoing, the Sub-Direction for Chemical Substances' and Narcotics' Control and Surveillance:

RESOLVES

Article 1. Modification of License. To modify the License for the cultivation of non-psychoactive cannabis plants, granted through Resolution No. 0230 of March 7, 2018, due to a change in connection with the licenseholder's legal representation, with the information of the corresponding updated license remaining as follows:

Paragraph 2. The activities authorized within the framework of this license shall be exclusively carried out by personnel employed by SATIVA NATIVA S.A.S., identified with TIN. 901.038.229-2, in the conditions established herein.

Article 2. Validity. The license granted through Resolution No. 0230 of March 7, 2018, modified through this Resolution, is valid until March 16, 2023 and may be recertified, prior the relevant application, filed three (3) months in advance to its expiration date.

Article 3. Compliance with the legal provisions. In its capacity as licensee of the License for the cultivation of non-psychoactive cannabis plants in the modalities indicated in Article 1 hereof, SATIVA NATIVA S.A.S., identified with TIN. 901.038.229-2, shall comply with the conditions specified in this administrative decision, that provided for in Decree 780 of 2016 (article 1 of Decree 613 of 2017), Resolutions 577 and 578 of 2017 of Ministry of Justice and Law, and the applicable legal provisions or those modifying or supplementing them.

Article 4. Payment. SATIVA NATIVA S.A.S., identified with TIN. 901.038.229-2, shall comply with Articles 4 and 5 of Resolution 230 of March 7, 2018 related to the payment of the installments corresponding to the licenses' follow-up and administrative and operative control services, and the accrual of any default interest.

The legal remedy of reconsideration against this decision must be lodged before the Sub-Direction for Chemical Substances' and Narcotics' Control and Surveillance of the Ministry of Justice and Law and the appeal before the Direction for Policy on Drugs and Related Activities of the Ministry of Justice and Law, with the personal notification hereof or within the ten (10) days following its notification.
