Through which a license for the manufacture of cannabis derivatives is granted to company SANTA MARTA GOLDEN HEMP S.A.S. is granted

THE MINISTER OF HEALTH AND SOCIAL PROTECTION

Exercising his powers, particularly those granted in Act 1787 of 2016, article 2.8.11.1.1 of Decree 780 of 2016 and Resolutions 2891 and 2892 of 2017 and,

CONSIDERING

That Book 2, Part 8, Title 11 of Decree 780 of 2016, subrogated by Decree 613 of 2017, establishes the obligations, conditions, and requirements of the license for the manufacture of cannabis derivatives for medicinal and scientific purposes, understood as those procedures allowing the obtainment of narcotics, including the production of resins, oils, tinctures, extracts, and preparations, as well as the refinement and transformation of certain narcotics into others.

That this Ministry issued Resolutions 2891 and 2892 of 2017, which set forth the provisions associated to the granting of the licenses to manufacture cannabis derivatives.

That company SANTA MARTA GOLDEN HEMP S.A.S., identified with TIN. 900993798-3, through filing 201742301811002 of August 22, 2017, applied for the granting of a license for the manufacture of cannabis derivatives in the modalities of: i) Domestic use; and ii) Exports, through the completion of form "GMTF04 - Application for a license to manufacture cannabis derivatives", which enclosed the relevant documentation in three hundred and forty-one (341) pages (Pages 1 to 341)

That the Direction for Medicines and Health Technologies of this Ministry, analyzed the information provided by SANTA MARTA GOLDEN HEMP S.A.S. and requested the missing documentation, through communication with filing number 201724001753101 of September 6, 2017 (Page 346).

That through filing 201742302088622 of September 21, 2017, SANTA MARTA GOLDEN HEMP S.A.S. answered the request made in thirty-eight pages (Pages 347 to 385).

That the Direction for Medicines and Health Technologies, after verifying compliance with all the technical requirements through Minute No. 28 of the meeting held on October 6, 2017: "recommends to approve the license to manufacture cannabis derivatives to SANTA MARTA GOLDEN HEMP S.A.S., in the i) Domestic use; and ii) Exports modalities (...)". (Pages 386 to 387).

That upon reviewing the record and following the technical area's recommendation, it is concluded that SANTA MARTA GOLDEN HEMP S.A.S. complies with the requirements provided for in the regulations in force; thus, the license to

In light of the foregoing.

RESOLVES

Article 1. Grant license 014 of 2017 for the manufacture of cannabis derivatives, in the modalities of i) Domestic use; and ii) Exports, to SANTA MARTA GOLDEN HEMP S.A.S. identified with TIN. 900993798-3, legally represented by Mr. Lucas Echeverri Robledo, identified with citizenship card number 79.237.963 of Bogotá D.C.

Paragraph. The manufacturing process can only be carried out in the property identified with real estate registration 080-5423, namely La Luisa – Rancho Lindo (2), located in vereda Bonda of the Santa Marta municipality - Magdalena, during the five (5) years of this license's validity.

Article 2. The license for the manufacture of cannabis derivatives granted through this administrative decision includes the receipt of the harvest and comprehends the manufacture of cannabis derivatives; and must be executed in accordance with the obligations set forth in Book 2, Part 8, Title 11 of Decree 780 of 2016, subrogated by Decree 613 of 2017, and Resolutions 2891 and 2892 of 2017.

Article 3. The titleholder of the license for the manufacture of cannabis derivatives granted through this resolution, prior to commencing activities, must have a license cannabis for the cultivation of cannabis plants and the quotas granted by this Ministry, pursuant to Resolution 2892 of 2017.

Article 4. The licenseholder's obligations under the cannabis derivatives' manufacturing license, in addition to those in otal article 2.8.11.5.1 of Decree 780 of 2016, include the following:

- 1. Comply with the terms, places, and conditions established for the obtainment of ordinary and supplementary quotas for the manufacture of cannabis derivatives.
- 2. Process before the Narcotics National Fund the favorable opinion for the quotas referred to in Article 27 of Resolution 2892 of 2017 and have the relevant supporting documents.
- 3. Have the supporting validation documents and physico-chemical analysis made on the psychoactive cannabis and its derivatives, to determine their THC, CBD, and CBN contents, complying with that provided for in paragraph three of the aforementioned Resolution 2892 of 2017, as well as the documentation on the analytical methodology applied.
- 4. Have the manufacturing supporting documents of each batch of psychoactive cannabis derivatives, including production orders and batch registration, with the relevant approvals and the industrial lots' formalization-liberation forms, as provided for by the Narcotics National Fund, in accordance with paragraph one of Article 28 of Resolution 2892 of 2017.
- 5. Implement the controls and forms for the transport of psychoactive cannabis derivatives, referred to in Article 35 of Resolution 2892 of 2017.
- 6. Submit the reports referred to in Article 29 of Resolution 2892 of 2017 and, once the Information Mechanism for Cannabis Control (IMCC) is in place, keep all updated information on this platform.

7. Have a technical director and his/her alternate, in accordance with article 6 of the aforementioned Resolution /o Notation 2892 of 2017.

8. Ensure the implementation and follow-up of the security protocol and inform the Narcotics National Fund of any news or changes in connection thereof.

Article 5. This Ministry shall declare the revocation of this administrative decision if the licensee incurs in any of the causes for termination referred to in Article 2.8.11.9.1, consistently with Article 2.8.119.2 of Decree 780 of 2016.

Article 6. To personally notify the contents of this resolution to the legal representative for SANTA MARTA GOLDEN HEMP S.A.S., identified with TIN 900993798-3, his agent or whoever is authorized for such purposes, at Calle 17 No. 3 - 83 of the city of Santa Marta, informing him that the legal remedy of reconsideration against this decision must be lodged in writing, with the personal notification thereof or within the ten (10) business days following the notification, in the terms provided for in article 76 of the Administrative Procedure and Contentious Administrative Code (APCAC).

Paragraph. If the personal notification cannot be made, that provided for in article 69 of the Administrative Procedure and Contentious Administrative Code shall be followed.

Article 7. To communicate the contents of this administrative decision to the U.A.E. Narcotics National Fund and the Sub-Direction for Chemical Substances' and Narcotics' Control and Surveillance of the Ministry of Justice and Law.

Article 8. This resolution shall take effect on the date it becomes final and unappealable.
