**ARTICLE 4.-** The person responsible for the cultivar's registration is required to comply with the legal provisions in Decrees 613 of April 10, 2017 and 631 of April 9, 2018, ICA Resolution No. 3168 of 2015, and other legal provisions supplementing, modifying, and/or substituting them.

**ARTICLE 5.-** The TROPICANA - AV008 Psychoactive Cannabis Cultivar under this registration, can only be commercialized in the natural Sub-region authorized herein.

**ARTICLE 6.-** To notify this administrative decision, delivering a complete and authentic copy, free of cost to the interested party, in accordance with Articles 67 to 69 of the Administrative Procedure and Contentious Administrative Code (Act 1437 of 2011).
