**RESOLUTION NUMBER 0713 OF JULY 31, 2018**

Through which a quota for the cultivation of psychoactive cannabis plants is allocated

**THE SUB-DIRECTOR FOR CHEMICAL SUBSTANCES' AND NARCOTICS'  
CONTROL AND SURVEILLANCE OF  
THE MINISTRY OF JUSTICE AND LAW**

Exercising her powers, particularly those granted in Act 1787 of 2016, Decree 1427 of 2017, Decree 613 of 2017, consistently with that provided for in Resolutions 577, 578, and 579 of 2017 of the Ministry of Justice and Law and, applying the provisions under the Administrative Procedure and Contentious Administrative Code, and

**CONSIDERING**

That through filing EXT18-0023643 of June 7, 2018, Mr. Lucas Echeverri Robledo, identified with citizenship card No. 79.237.963, in his capacity as legal representative for SANTA MARTA GOLDEN HEMP S.A.S., identified with TIN. 900.993.798-3, hereinafter the applicant, submitted an application for the allocation of a supplementary quota for the cultivation of psychoactive cannabis plants, in the scientific purposes' modality.

That complying with Articles 2.8.1.1.2.6.6. and 2.8.11.2.6.7. of Decree 780 of 2016 (article 1 of Decree 613 of 2017) and Articles 10, 11, and 12 of Resolution 577 of 2017 of the Ministry of Justice and Law, consistently with that provided for in Resolution 578 of 2017 of the Ministry of Justice and Law, the applicant submitted the documentation required to evaluate the application for the allocation of a supplementary quota for the cultivation of psychoactive cannabis plants in the modality applied for.

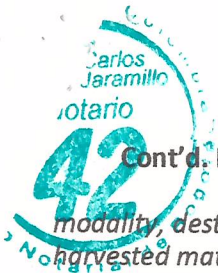
That in connection with the application and considering that provided for in paragraph 3 of article 2.8.11.2.6.3. of Decree 780 of 2016 (article 1 of Decree 613 of 2017), the Technical Group for Quotas determined during its extraordinary meeting of June 14, 2018, that additional information to that reported was necessary; thus, through OF18-0017134-SCF-3310, furnished on June 15, 2018, requested the submission of information to continue with the proceeding.

That through EXT18-0026205 of June 25, 2018, the applicant submitted a document with the additional information, which was fully analyzed by the Technical Group for Quotas during its meeting of July 6, 2018. According to the relevant minutes, the Technical Group for Quotas stated that:

*"Because the information provided by the applicant supplements the reasoning for the use of the plants applied for, the TGQ decides to approve a quota of 171 plants for the cultivation of psychoactive cannabis, in the scientific purposes"*

*modality, destined to carry out phenotypic assessments to establish a genetic selection program, following which, the harvested material shall be finally disposed of through composting."*

That pursuant to article 2.8.11.2.6.9. of Decree 780 of 2016 (article 1 of Decree 613 of 2017), the Technical Group for Quotas issued a binding evaluation opinion which, as provided for in the paragraph of article 2.8.11.2.6.3. of the mentioned regulations, must be adopted by the Sub-Direction for Chemical Substances' and Narcotics' Control and Surveillance of the Ministry of Justice and Law, through an administrative decision allocating the quotas, individually, to the licensee.

In light of the foregoing, the Sub-Direction for Chemical Substances' and Narcotics' Control and Surveillance:

**RESOLVES**

**Article 1. Quota.** In accordance with the Technical Group for Quotas' opinion, to assign a supplementary quota for the cultivation of psychoactive cannabis plants to SANTA MARTA GOLDEN HEMP S.A.S., identified with TIN. 900.993.798-3, in the following terms:

**Article 2. Validity.** This supplementary quota shall be valid from its allocation, up to December 31, 2018.

**Article 3. Compliance with legal provisions.** SANTA MARTA GOLDEN HEMP S.A.S., identified with TIN. 900.993.798-3 shall comply with the conditions specified in this administrative decision, that provided for in Decree 780 of 2016 (article 1 of Decree 613 of 2017), Decree 631 of 2018, Resolutions 577 and 578 of 2017 of Ministry of Justice and Law, and the applicable legal provisions or those modifying or supplementing them.

**Article 4. To personally notify** the contents of this Resolution to Mr. Lucas Echeverri Robledo, fully identified in the record, who may be summoned at email lucaseche@hotmail.com, delivering him a copy hereof. If the personal notification is not possible, that provided for in Article 69 of the Administrative Procedure and Contentious Administrative Code shall be followed.

**Article 5. Legal remedies.** The legal remedies of reconsideration and subsidiary appeal may be lodged against this decision.
