In exercise of his legal and statutory powers, particularly those granted in Decrees 4765 of 2008 and 1071 of 2015, Accord 005 of 2010, Resolution 1676 of 2011:

CONSIDERING:

That in accordance with Decree 1071 of May 26, 2015, ICA was authorized to regulate, supervise, and control the production, certification, multiplication, trade, import, and export of seeds for planting used in the domestic agricultural production.

That Article 6 of Resolution 3168 of September 7, 2015 issued by ICA, established that producers, exporters, traders, and/or importers of seeds for planting in the country, from cultivars obtained through genetic improvement as a result of applying scientific knowledge, as well as the agronomic assessment units and/or phyto-improvement research units, whether individuals or legal entities, must be registered with the Instituto Colombiano Agropecuario, ICA.

That Decree 613 of April 10, 2017, established the Registration with ICA for the production, import, trade, export, assessment, and research of seeds for planting pursuant to Resolution 3168 of 2015 issued by ICA.

That Mr. Lucas Pablo Nosiglia, in his capacity as legal representative for SATIVA NATIVA S.A.S., identified with TIN. 901.038.229-2, Trade Registration No. 183755, and judicial address for notice purposes at Carrera 1 No. 22 – 58, Office 903, Edificio Bahía, in the city of Santa Marta - Magdalena, pursuant to the Certificate of Existence and Legal Representation issued on December 18, 2018 by the Chamber of Commerce of Santa Marta for Magdalena, with its operational headquarters located at property Matogiro, Vereda El Curval, in the municipality of Santa Marta – Magdalena, through letter No.

20181132992, filed before the Technical Direction for Seeds, applied for a Selected Seed Producer (sexual and asexual) of psychoactive and non-psychoactive cannabis Registration.

That ICA made a technical visit to the operational headquarters on March 28, 2019 and, according to the report, a favorable prior opinion was issued for the obtainment of the registration applied for.

That the application was submitted and processed in accordance with the legal and regulatory formalities established under Resolution 3168 of September 7, 2015 issued by *Instituto Colombiano Agropecuario - ICA*.

In light of the above:

RESOLVES:

ARTICLE 1.- To grant the Registration as Selected Seed Producer (sexual and asexual) of psychoactive and non-psychoactive cannabis to company SATIVA NATIVA S.A.S., identified with TIN. 901.038.229-2, Trade Registration No. 183755, and judicial address for notification purposes at Carrera 1 No. 22 – 58, Office 903, Edificio Bahía, in the city of Santa Marta - Magdalena, pursuant to the Certificate of Existence and Legal Representation issued on December 18, 2018 by the Chamber of Commerce of Santa Marta for Magdalena, with its operational headquarters located at property Matogiro, Vereda El Curval, in the municipality of Santa Marta – Magdalena, as explained in the reasoning of this Resolution.

ARTICLE 2.- The Titleholder of the registration granted herein is required to comply with Resolution ICA 3168 of 2015 and any provisions regulating, modifying, repealing, or broadening the production of seeds.

ARTICLE 3.- In order to carry out the activities authorized under this registry, fully complying with the legal requirements, the Sub-direction for Chemical Substances' and Narcotics' Control and Surveillance of the Ministry of Justice and Law, shall have issued the license for the cultivation of psychoactive cannabis plants and the license for the cultivation of non-psychoactive cannabis plants.
